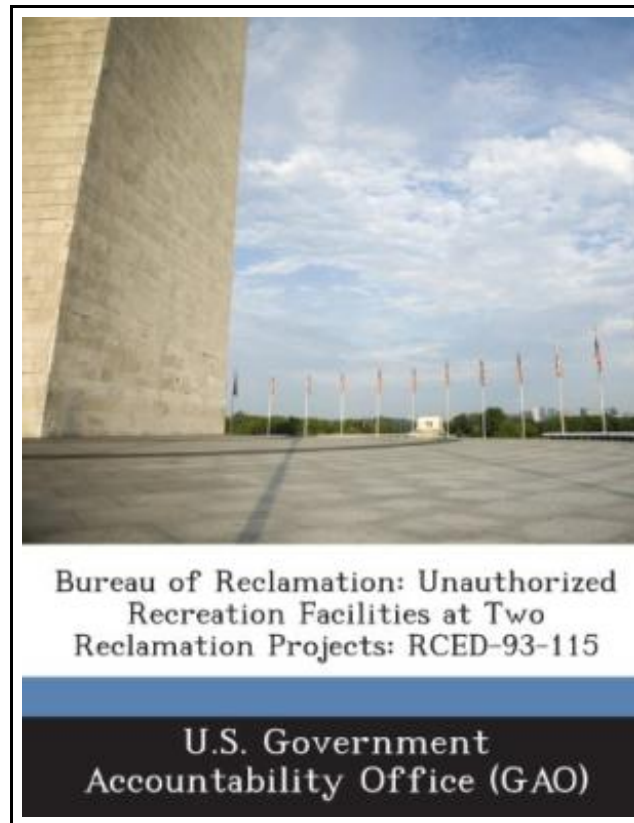

Pursuant to a congressional request, GAO reviewed the appropriateness of the Bureau of Reclamations expenditures for the Drainage and Minor Construction (D and MC) Program, focusing on whether: (1) some facilities constructed at federal water projects are recreational instead of minimum public health and safety facilities; (2) Reclamation has exceeded the authorized funds for constructing recreation facilities at these projects; and (3) Reclamation has entered into required cost-sharing agreements. GAO found that: (1) Reclamation has requested funds for minimum public health and safety facilities in its D and MC budget requests, but it has used some of those funds for recreational facilities at the projects; (2) although the Department of the Interior agrees that the recreational facilities do not constitute minimum public health and safety facilities, it believes that they are necessary to prevent the rapid deterioration of project reservoir resources; (3) Reclamation has exceeded authorized funding for recreation facilities at the projects; (4) Reclamation has not entered into all of the required cost-sharing agreements; (5) although Reclamation has shared some construction costs with nonfederal entities, it plans to allocate most of its funds to authorized irrigation and power projects; and (6) Reclamation has funded almost all operation and maintenance costs of the facilities because of its failure to enter into cost-sharing agreements.
